REPRINTED FROM REVISED YAKAMA CODE (R.Y.C.) 10.01.119 OPERATING A PUBLIC DANCE HALL

Any person or group of persons or organization who operates or maintains a public dance hall or other place of amusement where the public is permitted to attend on the reservation without first having obtained a license from the Tribal Council or fails to abide by the terms of the license with reference to safety, opening or closing hour and having a private security officer in attendance, shall be deemed guilty of an offense and, upon conviction thereof shall be sentenced to imprisonment for a period not to exceed ninety (90) days or pay a fine not to exceed \$250 or both, with costs [Annotation; Enacted by T-53-77 and T-127-60]
